Dear Judge Caproni:

We represent Plaintiffs in the above-captioned action. Pursuant to the Court's June 8 Order (Dkt No. 258), Plaintiffs have updated the chart at paragraph 264 of the Third Amended Complaint ("TAC") to correct for a computational coding error that was previously brought to the Court's attention, as well as the numerical figures in paragraphs 257, 263, and footnote 63.

In addition, Plaintiff seek leave to make a few minor changes to the TAC to bring it up-to-date. *First*, Plaintiffs propose to clarify allegations concerning two named plaintiffs and to remove two other named plaintiffs based on further analysis of trading records and in response to comments received from the Defendants during the initial phase of limited discovery. *Second*, Plaintiffs propose adding a few sentences to make note of the recent plea agreement and CFTC order that Plaintiffs brought the Court's attention on June 5. *See* Dkt. No. 261.

For the Court's convenience, Exhibit A to this letter identifies the specific changes that Plaintiffs propose to make to the TAC. Plaintiffs shared these changes with Defendants and counsel for UBS yesterday.
